All the Headmasters of Secondary Schools and Deputy Educational Officers in the district is hereby informed that, the Commissioner of School Education & Ex-Officio Project Director, RMSA, Andhra Pradesh, Amaravathi has issued instructions in the reference cited stated that an amount of **Rs.31,61,10,543/-(Rupees Thirty one crore sixty one lakhs ten thousand five hundred and forty three only)** unspent balance is available in the SMDCs in the state under Recurring and Non-Recurring prior to 2017-18 and interested accrued during the year 2018-19 and as per rules, these amounts have to be taken back from the SMDCs to the state office as the SMDCs have no power to utilize the previous year's unspent balances after completion of Financial Year and are accumulating year by year at the SMDCs and shows huge unspent amounts with regard to recurring grants and the unspent balance can be used as per the need basis among the High Schools like digital Class Rooms, Virtual Class Rooms, ICT etc.

Further, the Commissioner of School Education & Ex-Officio Project Director, RMSA, Andhra Pradesh, Amaravathi has issued instructions to the District Educational Officer and Ex-Officio Project Coordinator, RMSA in the state with a request to obtain and submit the unspent amounts available with the SMDCs(Recurring/Non-Recurring Grants) concerned be way of DDs for taking further action on or before 10.05.2019.
